The rape of a 16-year-old girl occurred in Steubenville, Ohio on the night of August 11, 2012. The victim in this case was incapacitated by alcohol and was sexually assaulted by two of her peers, and others had documented the act in Social media (Almasy,2013). The media focused the story on Trent Mays and 16-year-old Malik Richmond (Almasy,2013). They were sensational athletes that had promising futures in playing football after high school. During and after the trial, the media maintain their focus on the two assailants.

For instance, ABC News, seem to make excuses for the assailants. ABC ran an episode on the case on 20/20 (Lombardi, Lisa & Sean,2013).
